**AFFIRMATION OF CAMERON R. AZARI, ESQ. REGARDING IMPLEMENTATION
AND ADEQUACY OF NOTICE PLAN**

I, Cameron R. Azari, Esq., hereby declare and state as follows:

1. My name is Cameron R. Azari, Esq. I have personal knowledge of the matters set forth herein, and I believe them to be true and correct.

2. I am a nationally recognized expert in the field of legal notice and have served as an expert in hundreds of federal and state cases involving class action notice plans.

3. I am a Senior Vice President of Epiq Class Action and Claims Solutions, Inc. (“Epiq”) and the Director of Legal Notice for Hilsoft Notifications, a firm that specializes in designing, developing, analyzing, and implementing large-scale, un-biased, legal notification plans. Hilsoft Notifications is a business unit of Epiq. References to Epiq in this declaration include Hilsoft Notifications.

4. The facts in this declaration are based on my personal knowledge, as well as information provided to me by my colleagues in the ordinary course of my business at Epiq.

OVERVIEW

5. This declaration describes the successful implementation of the Notice Plan (“Notice Plan”) and notices (the “Notice” or “Notices”) for *McKinley et al. v. Conopco, Inc. et al.*, Index No. 805260/2024E, in the Supreme Court of New York, Bronx County. I previously executed my

Affirmation of Cameron R. Azari, Esq. Regarding Notice Plan, on July 1, 2024, which described the Notice Plan, detailed Hilsoft’s class action notice experience, and attached Hilsoft’s curriculum vitae. I also provided my educational and professional experience relating to class actions and my ability to render opinions on overall adequacy of notice programs.

NOTICE PLANNING METHODOLOGY

6. N.Y. CPLR 904 directs that in all other class actions, reasonable notice of the commencement of a class action shall be given to the class in such manner as the court directs.¹ The Notice Plan satisfies these requirements.

7. Implementation of the Notice Plan is ongoing with digital and social media notices and sponsored search listings still running. Once complete, the Notice Plan will reach the greatest practicable number of Settlement Class Members, reaching approximately 70% of the Settlement Class with a national digital/internet notice program (digital notice and social media). The reach is enhanced further by a newspaper publication, internet sponsored search listings, an informational release, and a Settlement Website, which are not included in the reach calculation. In my experience, the reach of the Notice Plan is consistent with other court-approved notice plans, is the best notice practicable under the circumstances of this case, and satisfies the requirements of due process, including its “desire to actually inform” requirement.²

NOTICE PLAN DETAIL

8. On August 14, 2024, the Court approved the Notice Plan and appointed Epiq as the Claims Administrator in the *Motion #1 Decision and Order* (“Preliminary Approval Order”). In the Preliminary Approval Order, the Court defined the Settlement Class as:

[A]ll persons who, from April 21, 2016 to the date this Preliminary Approval Order was signed by the Court³, purchased one or more Breyers Natural Vanilla ice cream products in the United States for personal or household use and not for resale.

Excluded from the Settlement Class and Settlement Class Members are: the Released Parties; any government entities; persons who made such purchase for the purpose of resale; persons who made a valid, timely request for exclusion; the presiding judges in the Actions; and mediator Peter Woodin of JAMS.

Media Plan Summary

9. The Media Plan includes various forms of notice including a national digital/internet notice program (digital notice and social media), a newspaper publication, internet sponsored search listings, and an informational release. Once complete, the combined measurable reach of the Notice Plan, including a comprehensive Media Plan (accounting for digital notice and social media only) will be approximately 70% of Adults, Aged 18+ in the United States who bought ice cream, with an average frequency of 2.4 times each. “Reach” refers to the estimated percentage of the unduplicated audience exposed to the notice. “Frequency,” in contrast, refers to how many times, on average, each member of the target audience had the opportunity to view the notice. The reach is enhanced further by a newspaper publication, internet sponsored search listings, an informational release, and a Settlement Website.

Internet Digital Notice Campaign

10. Internet advertising has become a standard component in legal notice programs. The internet has proven to be an efficient and cost-effective method to target class members as part of providing notice of a class action case. According to MRI-Simmons data, 97% of all adults in the United States who purchase Breyers Ice Cream are online and 85% of all adults in the United States who purchase Breyers Ice Cream use social media.⁴

11. The Notice Plan includes targeted Digital Notice advertising on the selected

advertising network *Google Display Network* and the *Yahoo Audience Network* (in English and Spanish), which together represent thousands of digital properties across all major content categories. Digital Notices are targeted to selected target audiences and are designed to encourage participation by Settlement Class Members—by linking directly to the Settlement Website, allowing visitors easy access to relevant information and documents. Consistent with best practices, the Digital Notices use language from the notice headline, which allows users to identify themselves as potential Settlement Class Members.

12. Digital Notices are also placed on the social media sites *Facebook* and *Instagram* (in English and Spanish), along with *TikTok*, *YouTube*, and *Reddit*. The *Facebook*, *Instagram*, *TikTok*, *YouTube*, and *Reddit* internet Digital Notices are distributed to a variety of target audiences, including those relevant to an individual’s demonstrated interests and/or likes.

13. *Facebook* is the leading social networking site in the United States with 175 million users and *Instagram* has 143 million active users in the United States.⁵

14. *TikTok* is a short-form, video sharing app that is very popular among younger users. Videos are in portrait orientation, and most are 30 seconds or less. The app has over 121 million users in the U.S.⁶

15. *YouTube* is the largest streaming video website in the United States with over 240 million users.⁷

16. *Reddit* is a widely used social forum website that contains more than one million communities known as subreddits. These communities cover specific topics making this an ideal

platform to reach individuals with focused interests. *Reddit* had an average of 41.5 million daily active users in the first quarter of 2024 in the United States.⁸

17. The Digital Notices are distributed to a variety of target audiences, including those relevant to individuals' demonstrated interests and/or likes. All Digital Notices appear on desktop, mobile, and tablet devices. Digital Notices on *Google Display Network* and the *Yahoo Audience Network*, *Facebook*, *Instagram*, *TikTok*, *YouTube*, and *Reddit* are targeted nationwide to reach Settlement Class Members. Digital Notices are also targeted (remarketed) to people who click on a Digital Notice.

18. More details regarding the target audiences, distribution, and specific ad size of the Digital Notices and the number of planned impressions are included in the following table.

19. Combined, more than 332 million impressions will be generated by the Digital Notices.⁹ The internet advertising campaign is running from September 13, 2024, through October 24, 2024. Clicking on the Digital Notices link the readers to the Settlement Website, where the readers can easily obtain detailed information about the case. Examples of the Digital Notices are included as **Attachment 1**.

Publication Notice

20. The Notice Plan included four insertions over four weeks in the “San Francisco,” “Los Angeles,” and “Phoenix” editions of *USA Today*. Each insertion was an approximate 1/4 page Publication Summary Notice. The Publication Notice is included as **Attachment 2**. The Publication Tear Sheets are included as **Attachment 3**. More details regarding the print publication is included in the following table:

⁹ The third-party ad management platform, ClickCease, is used to audit Digital Notice ad placements. This type of platform tracks all Digital Notice ad clicks to provide real-time ad monitoring, fraud traffic analysis, blocks clicks from fraudulent sources, and quarantines dangerous IP addresses. This helps reduce wasted, fraudulent or otherwise invalid traffic (e.g., ads being seen by ‘bots’ or non-humans, ads not being viewable, etc.).

Sponsored Search Listings

21. Sponsored search listings are being acquired on the three most highly visited internet search engines: *Google*, *Yahoo!* and *Bing*. When search engine visitors search on selected common keyword combinations related to the case, the sponsored search listing created for this case is displayed at the top of the visitor's website page prior to the search results or in the upper right-hand column of the web-browser screen. The sponsored search listings are displayed nationwide. All sponsored search listings link directly to the Settlement Website.

22. The sponsored search listings began on September 13, 2024, and will run through October 31, 2024. As of October 17, 2024, the sponsored listings have been displayed 25,960 times, which resulted in 2,238 clicks that displayed the Settlement Website. A complete list of the sponsored search keyword combinations is included as **Attachment 4**. Examples of the sponsored search listing as displayed on each search engine are included as **Attachment 5**.

Informational Release

23. To build additional reach and extend exposures, on September 13, 2024, a party-neutral Informational Release was issued nationwide over *PR Newswire's National U.S.1 and Hispanic Newslines* (in English and Spanish) to approximately 5,000 general media (print and broadcast) outlets, including local and national newspapers, magazines, national wire services, television and radio broadcast media across the United States as well as approximately 4,500 websites, online databases, internet networks, and social networking media.

24. The Informational Release included the address of the Settlement Website and the toll-free telephone number. The Informational Release served a valuable role by providing additional notice exposures beyond that which was provided by the paid media. The Informational Release (in English and Spanish) is included as **Attachment 6**.

Settlement Website

25. On September 13, 2024, Epiq established a dedicated website for the Settlement with an easy to remember domain name (www.VanillaIceCreamSettlement.com). Relevant documents are posted on the Settlement Website, including the Long Form Notice (in English and

Spanish), the Settlement Agreement, Preliminary Approval Order, Claim Form (in English and Spanish), Exclusion Form, and other case-related documents. The Settlement Website also provides the ability for Settlement Class Members to file an online Claim Form. In addition, the Settlement Website includes relevant dates, answers to frequently asked questions (“FAQs”), instructions for how Settlement Class Members may opt-out (request exclusion) from or object to the Settlement, contact information for the Claims Administrator, and how to obtain other case-related information. The Settlement Website address was prominently displayed in all notice documents. As of October 17, 2024, there have been 2,041,856 unique visitor sessions to the case website, and 6,943,383 web pages have been presented. The Long Form Notice in English is included as **Attachment 7**. The Long Form Notice in Spanish is included as **Attachment 8**. The Claim Form in English is included as **Attachment 9**. The Claim Form in Spanish is included as **Attachment 10**. The Exclusion Form is included as **Attachment 11**.

Toll-Free Telephone Number

26. On September 13, 2024, a toll-free telephone number (1-888-603-5137) was established for the Settlement. Callers are able to hear an introductory message and also have the option to learn more about the Settlement in the form of recorded answers to FAQs, and to request that a Long Form Notice and Claim Form (“Claim Package”), in English or Spanish, be mailed to them. This automated telephone system is available 24 hours per day, 7 days per week. The toll-free telephone number was prominently displayed in all notice documents. As of October 17, 2024, there have been 466 calls to the toll-free telephone number, representing 819 minutes of use.

27. A Claim Package in English or Spanish was mailed to all persons who requested one via the toll-free telephone number or other means. As of October 17, 2024, Epiq has mailed 131 Claim Packages as a result of such requests.

28. A postal mailing address and email address were established, allowing Settlement Class Members the opportunity to request additional information or ask questions.

Requests for Exclusion

29. The deadline to request exclusions from the Settlement or to object to the Settlement is October 31, 2024. As of October 17, 2024, Epiq has received 224 requests for exclusion. As of October 17, 2024, Epiq is aware of no objections to the Settlement.

Claim Submission & Distribution Options

30. The Settlement provides Settlement Class Members the option of filing a Claim Form. The Notices contained a detailed summary of the relevant information about the Settlement, including the Settlement Website address and how Settlement Class Members can file a Claim Form online or by mail. With any method of filing a Claim Form, Settlement Class Members are given the option of receiving a digital payment or a traditional paper check.

31. The deadline for Settlement Class Members to file a Claim Form is February 19, 2025. As of October 17, 2024, Epiq has received 1,120,673 Claim Forms (1,091,556 online and 1,200 paper). Since the claim filing deadline has not yet passed, these numbers are preliminary. As standard practice, Epiq is in the process of conducting a complete review and audit of all Claim Forms received. There is a likelihood that after detailed review, the total number of Claim Forms received will change due to duplicate and denied Claim Forms.

CONCLUSION

32. In class action notice planning, execution, and analysis, we are guided by due process considerations under the United States Constitution, by state rules and statutes, and further by case law pertaining to notice. This framework directs that the notice plan be designed to reach the greatest practicable number of potential class members and, that the notice or notice plan provide class members with easy access to the details of how the class action may impact their rights. All of these requirements were met in this case.

33. Once completed, the Notice Plan will have reached approximately 70% of the Settlement Class Members with a national digital/internet notice program (digital notice and social media). The reach is further enhanced by a newspaper publication, internet sponsored search

listings, an informational release, and a Settlement Website, which were not included in the reach calculation.

34. The Notice Plan followed the guidance for satisfying due process obligations that a notice expert gleans from the United States Supreme Court's seminal decisions, which emphasize the need: (a) to endeavor to actually inform the Settlement Class, and (b) to ensure that notice is reasonably calculated to do so.

- a) "[W]hen notice is a person's due, process which is a mere gesture is not due process. The means employed must be such as one desirous of actually informing the absentee might reasonably adopt to accomplish it," *Mullane v. Central Hanover Trust*, 339 U.S. 306, 315 (1950); and
- b) "[N]otice must be reasonably calculated, under all the circumstances, to apprise interested parties of the pendency of the action and afford them an opportunity to present their objections," *Eisen v. Carlisle & Jacquelin*, 417 U.S. 156 (1974) (citing *Mullane*, 339 U.S. at 314).

35. The Notice Plan provided notice that conformed to all aspects of the N.Y. CPLR 904 procedure regarding notice, and comported with the guidance for effective notice articulated in the Manual for Complex Litigation, Fourth and satisfied the requirements of due process, including its "desire to actually inform" requirement.

36. The Notice Plan schedule affords enough time to provide full and proper notice to the Settlement Class Members before any opt-out or objection deadlines.

I affirm this 21st day of October 2024, under penalty of perjury under the laws of New York, which may include a fine or imprisonment, that the foregoing is true, and I understand that this document may be filed in an action or proceeding in a court of law.

One-third of travel insurance claims are denied

Acceptance depends on a variety of factors

Travel insurance can help mitigate some unforeseen financial losses when a trip goes awry, from having to book an airport hotel following a flight cancellation or seeking medical care abroad.

With air travel at its busiest, an increasing number of travelers are turning to travel insurance before heading out on their trips – and putting it to good use. Travel insurance claim submissions have risen by 22% compared with last year, according to data from Squaremouth, a travel insurance comparison platform. And after a global tech outage that left thousands of air travelers stranded this summer, having travel insurance seems like a wise decision.

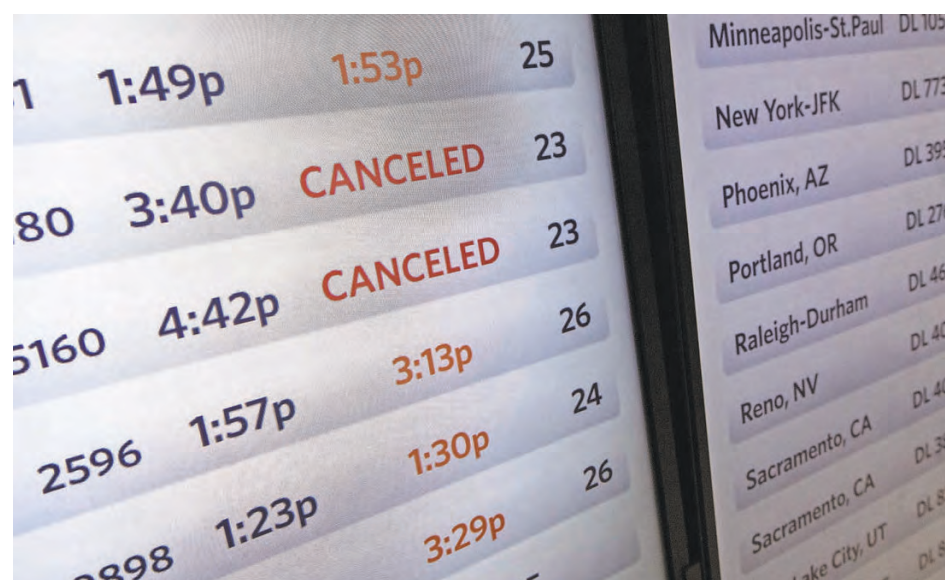
However, not all travel insurance claims are equal – or even accepted. Just having travel insurance is not a guarantee you'll get your money back for every travel mishap. "A lot of people go in with the understanding that everything bad that happened is covered by your travel insurance, but it's not a catch-all," Jenna Hummer, public relations director at Squaremouth, told USA TODAY. Not only have travel insurance claims increased, but so have the rates of denial. This year, travel insurance claim denials are up 33% over last year, according to Squaremouth data.

Having your claim accepted depends on a variety of factors, such as your coverage policy and having adequate proof of purchases, like all your receipts and notes from doctors. Hummer advises everyone to "know your policy" and be clear about what is covered.

Here are the top five reasons your travel insurance claim could be denied:

1. You're inconvenienced but not interrupted

While it would be great if travel insurance covered everything negative on your trip, that's not how it typically

works. "Things like not having a good time or having it rain the whole week on your beach vacation that you spent a lot of money on, those things are typically not covered," Hummer said.

2. You don't have a paper trail

If something that's under the policy does happen – like you get the flu and need to cancel your upcoming trip using travel medical coverage – make sure you keep that doctor's note and receipt for the visit for speedy processing. Claims often won't be reimbursed if you can't prove the expenses you incurred and authenticate your claim.

It's also worthwhile to keep your travel expenses well-organized. "It becomes a huge hassle later on when they're wading through all these receipts trying to get it together," Hummer said. (If you really can't find a receipt, bank or credit card statements usually work.)

3. Your disruption is actually not covered by the policy you purchased

Flight delays are almost always a headache, and unfortunately, your

eight-hour delay might not be covered by your travel insurance policy.

"It has to be listed on your policy to be covered," Hummer said. Some policies have a travel delay benefit that only includes missed connections or if your flight is delayed by a certain number of hours. Read the fine print or even call insurance providers to make sure you have a full understanding of what's covered before purchasing.

When a disruption does occur, call your insurance immediately. "Don't wait, don't call the airline, call the insurance provider ... and they'll give you everything you need to do in order to get the claim processed," she said.

While there is such a coverage option known as Cancel for Any Reason that lets you cancel up to a day before your trip, Hummer doesn't typically recommend this. "It is a very expensive add-on," she said. If someone has "something in their mind that they may need to cancel their trip," such as mental health-related or a fear of flying, then it could make sense.

4. You bought insurance too late

A comprehensive travel insurance

policy will cover anything due to inclement weather, like if your hotel loses power in a storm.

However, once severe weather, like a hurricane, is publicized, it's too late to purchase travel insurance.

If inclement weather is already underway, there's definitely no possibility of coverage.

"Once it's occurred, it's considered foreseen," Hummer said.

A good rule of thumb: buy your insurance as soon as you book your trip for the most coverage possible.

5. A preexisting medical condition makes you ineligible for your policy

Unfortunately, some travelers with preexisting medical conditions or illnesses may learn they're ineligible for the policy they purchased after the fact – they're also the ones who often need this type of coverage the most.

Many travel medical insurance policies don't provide coverage if you have a chronic condition or illness like heart disease or previous injuries, are pregnant, or are traveling abroad for an opt-in medical procedure like a facelift.

"That's one of the biggest misconceptions that we're constantly trying to educate travelers about," Hummer said.

Even just visiting the doctor for a bad knee without an official diagnosis of a condition could render a preexisting medical condition by your provider.

Many providers will cover individuals with preexisting medical conditions, provided there haven't been symptoms, doctor visits, or worsening of the condition during the "look-back period," which generally ranges from 60 to 180 days but varies based on your provider.

"You really have to make sure you have the coverage that you need," Hummer said. "The best way to do that is call the travel insurance provider and have them walk through your coverage."

It also is important to do this quickly once you book your trip since preexisting medical condition waivers are time-sensitive.

Spain, Brazil are best for tourism, solo travel

2 nations lead U.S. News & World Report 2024 list

Where in the world should you travel?

It depends on what you're looking for: beautiful scenery, friendly locals, great food.

Those were all factors U.S. News & World Report weighed for their Best Countries rankings, released Tuesday.

This year's rankings are based on the perceptions of nearly 17,000 survey respondents around the world, on topics running the gamut from military strength to public education.

"It's mostly like an association game," said Gary Emerling, U.S. News managing editor of government rankings, who oversaw the project. "Like, I think this is a friendly country. I know Canada is friendly, so I'm going to choose Canada for this one, not to stereotype."

Among the lists of superlatives spawned by the study, three European countries – Italy, Spain and France – topped the best countries for tourism.

Tourism itself is a subcategory under the larger umbrella of adventure.

Other attributes contributing to this year's adventure rankings include perceived friendliness, fun, pleasant climate, scenery and sexiness. Yes, sexiness.

U.S. News & World report separately ranked the best countries for solo travel.

"Within that, there's an attribute where we look at how safe countries are perceived as, and I think that's important for travelers to look at," Emerling said. "It's kind of what you would think – the Nordic countries, Switzerland on that list – but then, similar to ... the friendly attribute, we have one called unapproachable."

Iran, Kazakhstan, Myanmar, Uzbekistan and Russia were seen as the five most unapproachable countries, based on survey responses. Emerling noted current events can influence perceptions.

Medium hopes to connect with ‘Live’

Leading up to the premiere of his live Netflix series Tuesday night, renowned medium Tyler Henry experienced waves of excitement. He wants to reveal more about the process in which his sixth sense manifests through his first five senses.

“While sometimes I’ll get a taste or a smell or get kind of more of an audible impression in my head, visions are the primary way of communication, very strong, active imaginations or day-dreams,” he tells USA TODAY.

Henry also looks forward to addressing his skeptics with readings performed in real time. The curious check Google to see if he’s real. A firsthand account of a reading in 2022 proved very popular with our readers.

“I think that in being able to see it without that editing is extremely powerful in a way even more than we’ve previously seen,” the 28-year-old Henry says.

“Live From the Other Side With Tyler Henry,” an eight-episode weekly series (Tuesdays, 6 p.m. EDT/3 p.m. PDT), follows five seasons of E’s “Hollywood Medium” which introduced the Hanford, California native. guards,” Henry says with a laugh. “Which for skeptics is going to be really interesting to watch, and I think for believers could be very compelling if all goes as one hopes.”

In Tuesday’s premiere that was moderated by Amanda Kloots, guest Chrishell Stause brought her sister Shonda Davison, and friends including celebrity hairstylist Chris Appleton and television host Nina Parker.

Henry’s premonitions bounced among guests during the 43-minute program, which was not short on tears.

Henry felt Stause’s late mom’s love for Stevie Nicks. He also was able to relieve Stause’s regrets about the final words they shared.

“I hated my last conversation with her,” Stause revealed. “Is that something that she thinks about?”

Henry assured the “Selling Sunset” star that her mother doesn’t dwell on that chat. Parker became emotional when Henry connected her with a cousin who died in January at age 33.

But of course in life – even when you can connect with the dead – there are no guarantees.

And offer you a hard candy.

Because that’s the whole shtick of “Matlock” this time around. Andy Griffith played a disarming and powerful defense attorney as Ben Matlock in the original 1986-1995 series, but Bates isn’t whom you would pick as the most dominating lawyer in the room just by looking at her.

Her version of Matlock is a lawyer, too, but a corporate one, back in the workforce after long absent years due to personal trauma.

She wheedles her way into a fancy firm and starts showing the youngsters what’s what, all while pursuing her own agenda.

Matty surprises not only the audience and her legal enemies but also her co-workers and superiors, including boss Olympia (Skye P. Marshall), a Black woman and top-notch attorney who has

had to work harder than her peers to get where she is in her career. Olympia is constantly battling her ex-husband and firm nepo baby Julian (Jason Ritter, who does good smarm). Matty is a thorn in Olympia’s side and a fresh career competition for junior associates Billy (David Del Rio) and Sarah (Leah Lewis). Watching the Madeline-instigated side-show with amused disinterest is the firm’s head honcho Senior (Beau Bridges), who seems to hire Madeline as a private joke, but watches her closely.

It’s a big cast but creator Jennie Snyder Urman (“Jane the Virgin,” “Charmed”) has balanced the ensemble well in the humorous and well-paced scripts. In the first two episodes made available for review, there’s been time to get to know everyone *and* win two legal battles. The best procedurals can do both, and “Matlock,” especially after its big twist, certainly has ambitions as big as some of our best procedurals.

When Max’s “Hacks” – which stars Jean Smart, age 73 – won a boatload of Emmys last weekend, there was a lot of talk about making TV for and about people above a certain age. I’d argue that “Matlock” isn’t just for the Boomers. It’s yet more proof that stories about humans (and especially women) across the whole spectrum of our lives can be compelling. Matty Matlock can be a hero just like any of the young bucks on the latest Marvel show.

Great storytelling has no retirement age.

Are almonds nuts or fruits? Here's the scoop

Each year, the almond's popularity grows exponentially. Uses include almond butter, almond milk, almond paste and raw almonds to snack. Almonds are so popular, they were California's No. 1 agricultural export in 2021.

As popular as they are now, they've been around a really long time. Native to the Mediterranean where almond trees grew wild, they were cultivated as long ago as 3000 BC, according to Harvard's T.H. Chan School of Public Health. In fact, almonds are mentioned in Genesis, the first book of the Bible, as a food that can be given as a gift.

Have you ever wondered how almonds are harvested or where they're grown?

Here's the nutty background on almonds.

Where do almonds come from?

Almonds are seeds harvested from the fruit of the almond tree, *Prunus dulcis*.

The name "almond" comes from the common name of the tree species, but the name is used to identify the edible seed found in the fruit from the tree.

How do almonds grow?

An almond tree can grow up to 15 feet tall. The tree is known for its aromatic, white-pinkish flowers, and it grows fruit called a drupe, which resembles a peach or plum. The drupe fruit contains a small pit in the middle.

That pit is then harvested by a machine and prepared in several ways for consumption.

Where do almond trees grow?

Industrial producers plant almond trees in large orchards where climates are hot and dry in the summer and cool and moist in the winter.

Eighty percent of the world's almond supply is produced in California; the other 20% is found in Mediterranean countries such as Spain and Italy. California alone produces more than 25 species of almonds valued at \$4.7 billion, the Los Angeles Times reports.

Are almonds nuts?

Almonds do not fall under the botanical definition of nuts. According to the U.S. Department of Agriculture, nuts are single-seeded fruit with a high oil content, enclosed in a leathery or solid outer layer. Because almonds grow in the middle of a fleshy fruit, they are not classified as a nut.

There are two classifications for almonds: sweet and bitter.

Sweet almonds are the most common and easily accessible variation; they can be found in supermarkets and confections. These almonds are often processed and consumed like peanuts, walnuts and cashews.

Bitter almonds are not to be eaten like sweet almonds. These almonds have a high content of amygdalin, and consuming this chemical may be highly toxic for humans. Although bitter almonds are very similar to sweet almonds, they must undergo a different process for products to be completely safe. Whole bitter almonds are not used for snacking or baking – they are more often extracted for their oils to be safely used in medicine, liquor and select baked goods.

There's science behind fall colors' natural beauty

Easing into autumn is oh, so sweet – fall foliage, cozy sweaters and pumpkin everything.

Breaking out the autumn decor and want a color palette for inspiration? Here's everything you need to know about how fall colors became synonymous with the cooler months.

What are fall colors?

Fall colors are the shades that accompany the autumnal season, inspired by how the leaves change from green to an array of warm hues:

- Red
- Orange
- Yellow
- Brown

The beauty of fall lies in the variety of shades – you'll find crimson, golden-yellow and purplish-red leaves in many parts of the U.S. This color palette is also associated with other autumn imagery, like pumpkins, candy corn, apples, cranberries and turkeys.

Why do leaves change color?

Chlorophyll is what makes leaves green. Leaves also contain carotenoids, which produce yellow, orange and brown colors. In the autumn, they begin to produce more anthocyanin, which gives them red and purple hues.

As the nights get longer, chlorophyll production slows down and eventually stops, the U.S. Forest Service says.

When and how the leaves change color depends on tree species – some have leaves that turn brown and fall.

Weather and temperature also impact fall foliage. Warm, sunny days accompanied by cool nights make for

prime conditions. Extreme drought, excessive rainfall or warm periods, however, can negatively impact the range of fall colors. The latest forecast from the Climate Prediction Center predicts a warmer-than-average fall for nearly the entire United States.

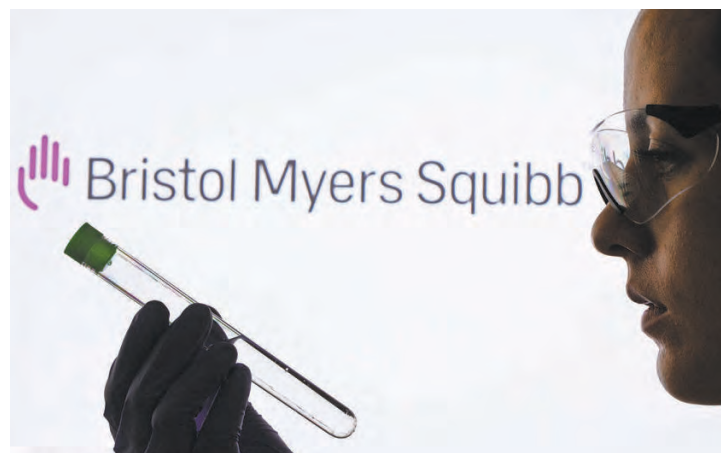
What is leaf peeping?

FDA-approved drug promises new way to treat schizophrenia

People with schizophrenia will have a new treatment option for the first time in more than three decades, after the Food and Drug Administration approved a new kind of drug Thursday.

Studies showed Bristol Myers Squibb's drug, KarXT, improved symptoms of schizophrenia and led to fewer side effects than existing antipsychotic treatments. Researchers are optimistic patients might stick with this medication longer than existing drugs, which patients often quit due to side effects.

KarXT is a twice-daily oral medication for adults that combines two drugs: Xanomeline, which targets muscarinic receptors in the brain, and trospium, which alleviates digestive and other symptoms that result from this type of medication. The promising drug combination was discovered and tested by Karuna Therapeutics, which Bristol Myers Squibb acquired in March.

Bristol Myers Squibb will sell the drug combination under the brand name Cobenfy. The pharmaceutical company hasn't said how much it will charge for the medication.

The nonprofit Institute for Clinical and Economic Review, which analyzes drug prices, said in January that the drug would be cost effective if priced between \$16,000 and \$20,000 per year.

In April, Bristol Myers Squibb released the results of a study that found three-quarters of patients saw their symptoms improve by 30% or more after one year on KarXT.

The KarXT approval comes after decades of no significant treatment advancements for schizophrenia patients. About 3.7 million, or 1.8%, of adults in the U.S. have a lifetime history of schizophrenia, according to 2023 research. The estimate was two to three times higher than previous estimates.

Doctors are hopeful KarXT will make a meaningful difference for patients who have struggled with existing antipsychotic medications, said Jelena Kunovac, a clinical assistant professor at University of Nevada, Las Vegas.

She said 75% of patients discontinue antipsychotics within 18 months, often due to stigma or side effects of existing drugs. Antipsychotics can cause weight gain, drowsiness, metabolic syndrome, which can increase risk of heart attack or stroke, or involuntary movements such as blinking or sticking out your tongue.

"The field is ready to try something different," Kunovac said. "This medication may be a game changer for some subset of patients."

Schizophrenia can cause people to hallucinate, struggle to control thoughts or become suspicious of others.

Researchers have tried without success to develop new class of schizophrenia medications since the last wave of dopamine-blocking antipsychotics emerged in the 1990s.

Last week, a study in the journal "Psychiatric Services in Advance" found that 70% of adults with schizophrenia had some type of mental health treatment in the past year. Only 30% were taking an antipsychotic.

Port strike puts automation into spotlight

NEW YORK – A strike by dockworkers on the U.S. East Coast and Gulf Coast that disrupted much of the nation's ocean shipping this week ended Thursday, but a key issue driving labor unrest across the continent – the growing use of automation – was unresolved.

Companies view automation as a path to better profit, while unions see it as a job-killer. For North American dockworkers battling automation, Europe's port worker contracts may point a way to resolve the issue.

About 45,000 port workers from the International Longshoremen's Association union ended a three-day strike late Thursday that had shut ocean shipping from Maine to Texas after reaching a tentative deal on wages.

The workers and port operators agreed to extend their contract to Jan. 15 while talks continued. A key sticking point in the negotiations for a new six-year labor contract is automation.

"We got to keep fighting automation and semi-automation," the union's leader, Harold Daggett, told a group of workers outside the Maher terminal in Elizabeth, New Jersey, as they held signs reading "Machines don't feed families" and "Fight automation, save jobs."

The union claims the use of an automated gate system at a port in Mobile, Alabama violates their contract.

The port is run by Netherlands-based APM Terminals, a member of the United States Maritime Alliance (USMX) employer group. The auto-gate system can process trucks entering and leaving the port using digital scans, without the help of unionized labor, the union says.

APM Terminals, owned by A.P. Moller-Maersk MAERSKb.CO, told Reuters that the auto-gate has been in place since the terminal opened in 2008 and that it remains in full compliance with the ILA/USMX master contract.

USMX declined to comment.

Canada fight

Automation has cropped up in other port labor disputes in the U.S. and Canada that have shaken global trade, stretching from Los Angeles to Vancouver.

In June, 99% of the International Longshore and Warehouse Union (ILWU) Local 514 workers in Canada rejected what was then called the final offer of the British Columbia Maritime Employers Association (BCMEA), covering seaports in the Canadian province.

The union was upset in part because logistics company Dubai Ports World Canada had put the labor group on notice that it would unilaterally introduce automation at a key rail yard at the Port of Vancouver.

"Workers are challenging automation because they know the negative effects

that disappearing jobs have on our families and communities," an ILWU Coast Longshore Division spokesperson said Tuesday.

The BCMEA and ILWU Local 514 have been negotiating on an industry-wide basis since November 2022.

Last year, more than 7,300 workers went on strike in Vancouver as automation became a sticking point with the BCMEA.

The ILWU sought to include language in contracts about training workers to repair new machinery introduced at the ports.

The Pacific Maritime Association (PMA), which represents terminal operators from California to Washington state, said union workers in 2023 "effectively shut down" terminals at ports including Los Angeles, Long Beach and Oakland in California when negotiations hit the 13-month mark.

A report underwritten by the ILWU representing West Coast dockworkers found that in 2020 and 2021, the Long Beach terminal had 392 fewer jobs than it would have had if it were not automated.

A competing report commissioned by the PMA found that paid hours at Los Angeles ports had risen by 31.5% since automation began in 2016. The authors declined to provide figures for Long Beach alone.

In the new six-year contract, the union and PMA said they would estab-

lish a minimum staffing agreement for terminals that introduce automated equipment and discuss new technological changes.

European contracts

In Europe, port workers unions have already negotiated protections against automation, after Europe Container Terminals opened the world's first automated container terminal in Rotterdam, the Netherlands, in 1993, according to Berardina Tommasi, policy officer at the European Transport Workers' Federation for dockworkers.

"Nobody can be sacked because of automation," said Niek Stam, secretary of FNV Havens, the largest Dutch dockworkers union.

The Dutch union has more than 6,000 members across three ports in the Netherlands, including the Port of Rotterdam, which is considered one of the most technologically advanced in the world. "We've had this in our contracts for many years," Stam said.

Even so, the union is looking to address concerns around automation in its current contract negotiations over worries about career longevity as automation reduces the number of less intense roles at ports.

"We have to talk about early retirement (with terminal operators) because workers can't work until 67 doing the most labor-intensive jobs," Stam said.

Long-delayed 3½-year cruise finally begins its voyage

Villa Vie Residences' 3½-year cruise has officially begun.

The long-delayed sailing departed Belfast, Northern Ireland, where its Villa Vie Odyssey ship has been docked in recent months, for its first stop on Thursday, according to an Instagram Story posted by the company.

The ship will spend a day at sea before arriving in Brest, France, late on Friday according to resident Victor Torres. "You can see everyone's mood," Torres, who was previously based in Los

Angeles, told USA TODAY. "It's festive, exciting."

Torres, 53, who is sailing with his wife, Shristie, said residents boarded the ship Monday night but were told it would take until at least Tuesday to leave Belfast because of remaining paperwork. "Even though we weren't able to leave the harbor for the first two days or two nights, you know, everyone's still very upbeat," he said.

A spokesperson for Villa Vie confirmed the ship was on its way to Brest but did not provide a comment on the specifics of Torres' experience.

The cruise had been scheduled to

start in May but faced a number of setbacks. Villa Vie CEO Mikael Petterson told USA TODAY in August that the company had "been quite humbled by the scale of what it takes to reactivate a 30-year-old vessel from a four-year lay-up."

The Odyssey had sailed as Fred Olsen Cruise Lines' MS Braemar. Villa Vie purchased it in 2023.

Torres, who is retired, already planned to visit other countries, three

months at a time, over the next several years before learning about Villa Vie. When the opportunity to travel without repeatedly unpacking arose, he jumped at it, selling most of his belongings and moving with three suitcases.

Torres spent the months during the delays traveling anyway. He said he took a weeklong cruise and a trip to the Canary Islands – paid for by Villa Vie – and set out on his own to explore Europe, where he had never been, from Barcelona, Spain, to Prague in the Czech Republic and many other destinations (Villa Vie also offered reimbursement for those trips).

Southern end of Appalachian Trail devastated by Helene

Travelers hoping to hike the Appalachian Trail are being asked to stay away from its southern portion, which is still reeling from Helene.

Helene was no longer a hurricane by the time it reached the start of the storied trail in North Georgia last week, but its extreme rains caused devastating floods across the Southeast.

The Appalachian Trail Conservancy, which oversees the management and conservation of the trail stretching from Georgia to Maine, shared in a news release:

Hurricane Helene is the largest natural disaster – in terms of geographic footprint – to impact the Appalachian Trail in its 100-year history. While it is still too early to understand the extent of the damage to the A.T. itself, hundreds of thousands of people throughout the Southern Appalachians – including ATC staff – have been impacted by flooding, strong winds, tornadoes, downed trees, and impassable roadways, and are without power, clean water, internet, and other essentials.

Several national forests along the trail are closed, and other areas are discouraging visitors so they can focus on recovery.

Where was the trail affected?

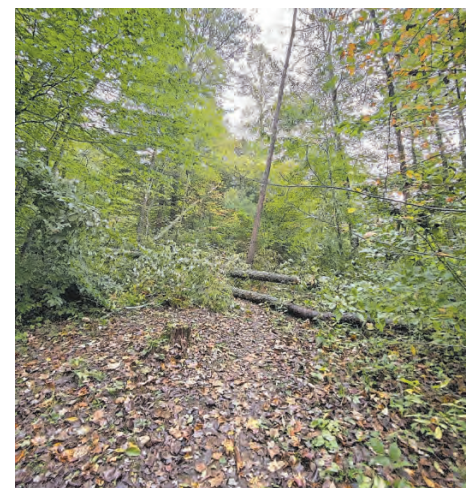
Hikers are urged to avoid northbound mile 0.0 on Georgia's Springer Mountain to mile 864.6 in Rockfish Gap, Virginia.

"Although not all areas in this section are officially closed, there is still a risk of landslides in many areas, much of the A.T. in the south is inaccessible due to road closures, and emergency responders are at max capacity," the ATC posted in an update Wednesday. "There also may be dangers on the Trail from the storm like downed trees, severe erosion, washed out bridges, and swollen creeks and streams."

How long will areas be closed?

It's not clear how long it will take to reopen the full trail.

"We also ask for patience as recovery

and relief efforts in the impacted communities continue and critical infrastructure is restored," Appalachian Trail Conservancy Communications Director Ann Simonelli told USA TODAY by email. "Once we can safely access the A.T., the ATC and our partners will begin to fully evaluate the Trail's conditions."

The ATC is maintaining a list of trail closures on its website. Updates are also available on the websites of the various public lands through which the trail crosses. Great Smoky Mountains National Park, for instance, is discouraging hiking and backcountry travel for the time being, and Nantahala and Pisgah National Forests are temporarily closed.

What can hikers do?

Hikers who had been working to achieve 2,000-miler status for completing the entire Appalachian Trail may suspend their hikes and pick up where they left when it's safe to do so.

"They will have 12 months from the date they choose to resume their hikes to complete the remainder of their journeys and still be recognized by the ATC as a thru-hiker," according to the ATC, which also shared resources for helping residents of communities recover from the storm.

BASIC INFORMATION

1. Why is this Notice being provided?

A state court authorized this Notice because you have the right to know about the proposed Settlement of this class action lawsuit and about all of your rights and options before the Court decides whether to grant final approval to the Settlement. This Notice explains the lawsuit, the Settlement, your legal rights, what benefits are available, who is eligible for the benefits, and how to get them.

The Honorable Veronica G. Hummel, Justice of the Supreme Court of the State of New York, Bronx County, is overseeing this class action. The lawsuit is known as *McKinley et al. v. Conopco, Inc. et al.*, Index No. 805260/2024E. The persons who filed the lawsuits are called the “Plaintiffs” or “Class Representatives” and the companies sued, Conopco, Inc., and Unilever United States, Inc. are called the “Defendants.” This Settlement is on behalf of a nationwide class and covers all pending litigation, including a related action pending elsewhere. For more information regarding the related action pending elsewhere, please see section 1.3 of the Settlement Agreement available on the Settlement Website.

2. What is this lawsuit about?

Plaintiffs filed this lawsuit against the Defendants alleging the Defendants’ labelling of Breyers® Natural Vanilla ice cream gave consumers the impression the ice cream contained vanilla flavor derived only from the vanilla plant and not from non-vanilla plant sources, and allege that it contained non-vanilla plant vanilla flavors. The Defendants dispute all of these allegations and deny any wrongdoing. The Court has not decided who is right.

3. What is a class action?

In a class action lawsuit, one or more persons called plaintiffs sue on behalf of other persons that have similar legal claims. The people are a “class” or “settlement class members.” In this lawsuit, the people who sued are called the “Plaintiffs.” The companies and people they are suing, Conopco, Inc., and Unilever United States, Inc. are called the “Defendants.” One court resolves the issues for everyone in the class, except for those people who choose to exclude themselves (opt out) from the class.

4. Why is there a Settlement?

The Court has not decided in favor of the Plaintiffs or the Defendants. Instead, both sides agreed to a Settlement to avoid the cost and risk of a trial. Settlement Class Members may submit a Claim Form for a cash payment. The Plaintiffs and Class Counsel believe the Settlement is best for the Class and represents a fair, reasonable, and adequate resolution of the lawsuit.

The Defendants deny the legal claims in the lawsuit; deny all allegations of wrongdoing, fault, liability or damage to the Plaintiffs and the Settlement Class; and deny they acted improperly or wrongfully in any way. The Defendants nevertheless recognize the expense and time that would be required to defend the lawsuit through trial and have taken this into account in agreeing to the Settlement.

WHO IS IN THE SETTLEMENT?

To see if you are eligible for a cash payment, you first have to determine if you are a Settlement Class Member.

5. Am I part of the Settlement?

You are a Settlement Class Member if you are a consumer who purchased the Product in any size in the United States from April 21, 2016, through August 14, 2024.

“Product(s)” means Breyers® Natural Vanilla ice cream, in any size. A complete list of the Products can be found at www.vanillaicecreamsettlement.com.

You are excluded from being a Settlement Class Member if you are (a) the Released Parties; (b) any government entities; (c) persons who made such purchase for the purpose of resale; (d) persons who made a valid, timely request for exclusion; (e) the presiding judges in the Actions; or (f) mediator Peter Woodin of JAMS.

THE SETTLEMENT BENEFITS – WHAT YOU CAN GET**7. What does the Settlement provide?**

As a result of the Settlement, the Defendants have agreed to create a Settlement Fund of \$8,850,000. Cash payments from the Settlement Fund will be paid to each Settlement Class Member who submits a valid and timely Claim Form.

Monetary Benefits Available to Settlement Class Members: Settlement Class Members who submit a valid and timely Claim Form by the deadline are eligible for the following cash payments (“Monetary Benefits”):

If you file a valid and timely Claim Form, you will not receive a cash payment until any appeals are resolved. Please be patient.

10. What am I giving up to receive a cash payment from the Settlement?

Unless you exclude yourself (“opt-out”) from being a Settlement Class Member by timely submitting a request for exclusion, you will remain a Settlement Class Member. This means you cannot sue, continue to sue, or be part of any other lawsuit against the Released Parties about the legal issues in this lawsuit. It also means that all of the Court’s orders will apply to you and legally bind you and that you will release the legal claims detailed in the Settlement Agreement. 12. How will the lawyers be paid?

Class Counsel will request Attorneys’ Fees and Costs up to \$3,175,000. In addition, Class Counsel intends to request the Court approve Service Awards to each of the Class Representatives (Frederick McKinley and Lisa Vizcarra) in the amount of \$5,000 for their efforts in pursuing this lawsuit. If awarded by the Court, these Attorneys’ Fees and Costs and the Service Awards will be paid from the Settlement Fund. The Court may award less than these amounts for the Attorneys’ Fees and Costs and Service Awards.

YOUR RIGHTS – EXCLUDING YOURSELF FROM THE SETTLEMENT

If you want to keep the right to sue or continue to sue the Released Parties for the legal claims in this lawsuit, and you do not want to receive a cash payment from this Settlement, you must take steps to exclude yourself from the Settlement. This is called “**excluding yourself**”—or is sometimes referred to as “**opting out**” of the class.

13. How do I exclude myself from the Class?

“Mass” or “class” requests for exclusion filed by third parties on behalf of a “mass” or “class” of Settlement Class Members or multiple Settlement Class Members where no Exclusion Form has been signed by every individual Settlement Class Member will not be allowed.

14. If I exclude myself, can I get anything from this Settlement?

If you choose to exclude yourself from the Settlement, you are telling the Court that you do not want to be a Settlement Class Member and you will not be bound by the Settlement or any judgment in this lawsuit.

You can only get a cash payment if you remain a Settlement Class Member and submit a valid and timely Claim Form as described above. If you remain a Settlement Class Member, you will be bound by the Settlement or any judgment in this lawsuit.

If you choose to exclude yourself from the Settlement, you are not giving up the right to sue the Released Parties for the legal claims this Settlement resolves and releases. Your objection must contain the following:

- Your full name, current address, and telephone number;
- The name, address, and telephone number of any lawyer representing you, if any, including any former or current lawyer who may be entitled to compensation for any reason if the objection is successful and their legal and factual support for the right to such compensation;
- Documents or testimony sufficient to establish your membership in the Settlement Class;
- A detailed statement of any objection asserted, including the grounds for the objection;
- Whether you are requesting the opportunity to appear and be heard at the final approval hearing and the reasons for your request;
- The identity of your lawyer (if any) who will appear at the final approval hearing and a list of all persons who will be called to testify in support of the objection (if any);
- Copies of any papers, briefs, or other documents upon which the objection is based;
- A detailed list of any other objections by you, or your lawyer, to any class litigations submitted in any state or federal court in the United States in the previous five (5) years (or affirmatively stating that no such prior objection has been made); and
- Your signature, in addition to the signature of your lawyer (if any).

Settlement Class Members who fail to make objections in the manner specified in this Section will be deemed to have waived any objections and will be prevented from making any objection to the Settlement (whether by appeal or otherwise).

Any objection to the Settlement must be in writing. If you submit a timely written objection, you may, but are not required to, appear at the Final Approval Hearing, either in person or through your own lawyer. If you appear through your own lawyer, you are responsible for hiring and paying your lawyer.

16. What is the difference between objecting and asking to be excluded?

Objecting is simply telling the Court that you do not like something about the Settlement. You can object only if you remain a Settlement Class Member (meaning you do not exclude yourself). Excluding yourself is telling the Court that you do not want to be a Settlement Class Member. If you exclude yourself, you cannot object because the Settlement no longer affects you.

YOUR RIGHTS – APPEARING AT THE FINAL APPROVAL HEARING

The Court will hold a “Final Approval Hearing” to decide whether to approve the Settlement. You may attend and you may ask to speak if you submit an objection by the deadline, but you do not have to.

17. When and where will the Court decide whether to approve the Settlement?

The Court will hold a Final Approval Hearing to decide whether to approve the Settlement. You may attend this hearing and you or your lawyer may speak at the hearing if you submitted an objection, but you or your lawyer do not have to do so. The Court will hold the Final Approval Hearing at **9:30 am on November 21, 2024**, at the Supreme Court for the State of New York, Bronx County, located at 851 Grand Concourse, Bronx, New York, 10451.

Note: The date and time of the Final Approval Hearing are subject to change without further notice to the Settlement Class. The Court may also decide to hold the hearing via Zoom or telephonically. You should check the Settlement Website www.vanillaicecreamsettlement.com to confirm the date of the Final Approval Hearing has not changed.

At the hearing, the Court will consider whether the Settlement is final, fair, reasonable, and adequate. If there are objections that were postmarked by the deadline, the Court will consider them. If you submit a timely objection, and you would like to speak at the hearing, the Court will also listen to you or your lawyer speak at the hearing, if you so request.

If the Court approves the Settlement, the Settlement Benefits, including cash payments to Settlement Class Members who submit a timely, valid, and approved Claim Form, will be provided after any appeals are resolved and after the completion of all Claim Form processing. 19. May I speak at the Final Approval Hearing?

Yes, as long as you do not exclude yourself, and you submit an objection, you or your lawyer can (but do not have to) participate and speak in this litigation and Settlement. This is called making an appearance. You also may have your own lawyer speak for you at the hearing, but you will have to pay for the lawyer yourself.

Las personas que presentaron las demandas se denominan los “Demandantes” o los “Representantes del grupo” y las compañías demandadas, Conopco, Inc. y Unilever United States, Inc. se denominan los “Demandados”. Esta Conciliación es en nombre de un grupo de demandantes a nivel nacional y cubre todos los litigios pendientes, incluida una demanda relacionada, pendiente en otro lugar. 2. ¿De qué trata esta demanda?

Los demandantes presentaron esta demanda contra los demandados alegando que la etiqueta del helado Breyers® Natural Vanilla daba a los consumidores la impresión de que el helado contenía sabor a vainilla derivado únicamente de la planta de vainilla y no de fuentes vegetales distintas a la vainilla, y alegan que contenía sabores a vainilla de plantas que no eran plantas de vainilla. Los demandados cuestionan todas estas acusaciones y niegan haber actuado mal. El Tribunal no ha decidido quien tiene razón.

3. ¿Qué es una demanda colectiva?

En una demanda colectiva, una o varias personas denominadas demandantes presentan una demanda en nombre de otras personas que tienen reclamaciones legales similares. Estas personas constituyen el “Grupo de demandantes” o son los “Miembros del grupo del Acuerdo”. En esta demanda, las personas que demandaron se denominan los “Demandantes”. Las compañías y las personas a las que demandan, Conopco, Inc. y Unilever United States, Inc. se denominan los “Demandados”. Un tribunal resuelve los asuntos para todo el grupo de demandantes, excepto para quienes deciden excluirse (exclusión) de dicho grupo.

4. ¿Por qué existe una Conciliación?
